In reference to subject cited above as per earlier communication the matter has been put up in the 5th BoG meeting as agenda item No. 5.8 held on 23rd August, 2019. As per the BoG the resolution has been passed as below:

"Hon'ble members discussed and concluded that the expenditure has made as per earlier decision taken in the 5th BoG meeting of ECB society. After declaring this Institute as constituent college of Bikaner Technical University, the same payment was given. But as per audit report expenditure of Rs. 101667.00 (One Lakh One Thousand Six Hundred Sixty Seven Only) has been disallowed, which was not correct as per BoG discussion. Therefore, keeping in view of the above facts BoG decided that a letter should be written to SPIU/NPIU for allowing this expenditure.

Further, it is decided that after approval of SPIU/NPIU, the payment of TEQIP Staff engaged will be paid as per TE order no. 2015/T.E/04 dated 01/05/2018, in which wages are inclusive of all like PF, ESI, ST excluding GST which will be extra payable to contractor."

Now you are requested, please allow the expenditure for Rs. 101667.00 (One Lakh One Thousand Six Hundred Sixty Seven Only) and to drop the audit observation/objection of Audit Report FY 2018-19.
