## **Additional Terms & Conditions**

1. Letter of Authorization in the name of participating firm/supplier from Manufacturer/OEM is mandatory without which quotation will not be considered for evaluation.
2. Make must be as per Group-A of Latest BSR of PWD, Govt. of Rajasthan.
3. All the batteries of each rating have to be single batch not older than three months.
4. Warranty: Not less than 24 months.
5. Installation: The batteries have to be properly connected with each other and with the UPS including setting of charging current. All old connectors and cables to be replaced. Batteries are to be installed as following
  - a. 12V, 28AH 16 Banks of 26 batteries, 01 Bank of 17 Batteries and 01 Bank of 12 Batteries.
  - b. 12V, 45AH 2 Bank of 25 Batteries each.
6. In case of failure/replacement of 4 batteries of any one bank or failure/replacement during warranty period, all the batteries of the corresponding bank have to be replaced with new batteries of the same batch not older than 3 months.
7. Make of each type of battery have to be specified separately.
